

In 2020, HCCF awarded total grants and scholarships of over \$1.7 million through a variety of funds to organizations serving every corner of Hendricks County. We continued engaging our donors to match their passions to areas of need in the community and developed a Community Unity Program to lead the way in bringing our county together.

In March, HCCF pivoted immediately with its unrestricted funds as well as grant dollars from 22 other funds to respond to the pandemic, totaling \$535,000 in grants in 2020.




