#### **ARPA Funds Making an Impact**

The Community Foundation, in cooperation with the County Council and Commissioners, created a <u>grant program</u> to distribute up to \$6.6 million of American Rescue Plan Act funds allotted to Hendricks County. Last year, <u>HCCF distributed</u> over \$548,000 in competitive grants to 25 local nonprofits.

One of the grant recipients was The Little Red Door Cancer Agency, which received **\$24,500** to be used for Hendricks County patients' transportation and nutrition supplements.

The second year of ARPA grant applications closed in July and grants will be awarded by December 2023.
